Appendix I: 2020 Water Report to May 6

- Nov. 30, 2019 was first ice on Lower Twin Lake (LTL) at 14 ft. 2in. No water at the dam Water Canada Gauge (WCG) and Turtle Pond (TP) is minus 4 horizontal ft. from the WCG.
- April 2020 snow pack report 119 % according to snow gauge on Kabau Mt. near Oliver.
- April 12 small flow of water through the culverts on DL 1469s White Lake Rd. S. for about 40 ft. LTL at 14 ft. 4.75 in. Minimal water spilling from UTL to dam area from snow melt with dam at .15 meters (m).
- April 15 was ice off UTL & LTL after light rain April 14.
- April 18 a small water flow to UTL from Horn Creek. There appeared to be an average flow through the culverts at DL 1469s filling rocked in creek bed.
- April 22 Dam area was filling some as WCG .21m. LTL was at 14 ft. 5 in. (rise of lake level from snow melt & maybe seepage).
- May 1 Sportsman bowl reported some flooding. Myers Creek flow at the White Lake Rd. Horn Creek crossing appeared to be about what was observed in Horn Creek culverts on DL 1469s
- May 2 was a small flow over the 40 ft. spillway with dam WCG at 1+ meter. Dam culvert closed as per Nature Trust water licence until June 30. By May 3 increased flow through the culverts on DL 1469s reported and water over spillway was 3 in. deep. Turtle Pond was filling.
- May 4 Turtle Pond filled to .4m on WCG.
- May 5- water into LTL with a strong flow filling the channel between 437 & 433 Eastview Rd. WCG on TP is now covered. LTL was at 14 ft. 8 in. which is up 3 in. in the past 24 hr. Some light rain early am.
