b. 2018 AGM motion was: 1) "That the LNID convert to a Service Area (SA) of the RDOS with recommendations from Don Dobson/letter of intent." 2) "That the RDOS identify the scope and the cost of the conversion and with the intent of having a LNID vote once costs are determined". **Conversion to a RDOS Service** Area (Service Area is a legal term to provide authority for RDOS management)– unable at this time as RDOS confirmed April 16/19 that they voted against creating a drainage Service Area on Nov/18. LNID were not notified by RDOS and LNID must continue.

5. Election of a Trustee for a 3 year term.

6. New Business & Questions-

a) The solution for Twin Lake's protection of water quality & quantity is restoring the 1950-1961 gravitational, gate control, overflow pipe through DL 280 on LNID Statutory Right of Way to Lower Horn Creek.

b) The Park Rill & Twin Lake Flood Report funded by the province was presented to RDOS May 1/19.

c) Funding for a Park Rill Master Management Study has been secured by Area C (Willowbrook & Rural Oliver) Director, Rick Knodel.

d) "Flood & Drought Mitigation" along with climate change is being discussed by our complaint driven, **reactive not proactive BC Govt.**

e) Water officials agree that restoration of creeks & wetland storage helps to mitigate flood & drought in the face of climate change & development, but this is beyond the LNID Mandate.

Mandate of the LNID

We are a Land Improvement District (not an Irrigation District) "to divert or impound water to protect property, to facilitate development of a park or to reclaim or drain land for similar purposes". In order to carry out our mandate the LNID has monitored and checked the Horn Creek waterway for debris/blockages, recorded and reported lake levels, done clarity tests, and taken a beach water sample annually. We have a members list, history of the area and 2 diversion water licenses. The 1973 Botham Report gives a history and describes a co-operative control of the Twin Lakes Waterway System. A hydrometric station was established on Lower Twin Lake in 1968 & 2 Observation Wells (see BC Water Atlas #404 & 403 wells) in Feb.2011. We provide some water education – "Protect our water, aquifer and watershed". We are concerned about water quality and quantity. We communicate with RDOS and different Ministries as necessary - MoE, MoFLNRO, MoMAH, MoTI and OBWB. We attend relevant meetings, webcasts and respond to decisions which affect us.
