A motion that the Trustees investigate the sewage disposal from the cabins of the Twin Lake Guest Ranch. Moved by Mrs. Webb, - Seconded by Mr. Harry Ellis, CARRIED.

A motion that the trustees look into the purchase of two fire pumps and hoses one for either side of the lake. Moved by Mr. Webb, seconded by Mr. Harry Ellis, CARRIED.

A motion to have a new tax levie of thirty dollars (\$30.00) for the coming year. Moved by Mr. Harry Ellis, - Seconded by Mr. Webb, CARRIED.

Next meeting to be called for late August or early September at Twin Lakes.
